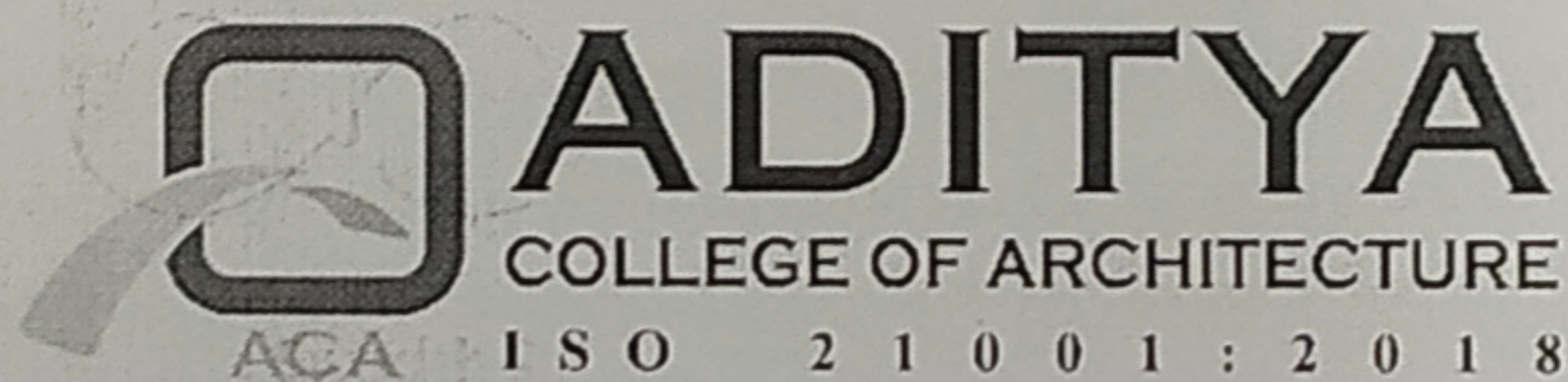

(Hereinafter referred to as "Aditya College").

"Aditya College" and "ReCircle" shall hereinafter be individually referred to as "Party" and collectively referred to herein as "Parties".

Purpose:

This MOU outlines the general understanding and framework for collaboration between ReCircle and Aditya College to promote and advance (the "Purpose") through various activities and initiatives.

Whereas:

1. Aditya College is the best Architecture Degree College that provides quality education to build up a career as Architecture in Mumbai
2. ReCircle is a global waste transformation leader, generating environmental, social and economic value through innovation, for a circular future that benefits all.
3. Aditya College of Architecture, with its aim for bringing sustainable development has approached ReCircle to provide recycling/dry waste pick up solutions as per the terms mentioned in the MOU below.
4. The Parties hereby agree that this MOU is in supersession of all arrangements, oral or in writing that may have been executed between the parties.

Now, therefore, in consideration of the mutual covenants and MOUs contained herein, the adequacy and sufficiency of which are expressly acknowledged by the Parties hereto, the Parties agree as follows:

The Memorandum Of Understanding between the two parties is set out below:

1. **Scope of Collaboration:** ReCircle and Aditya College agree to collaborate on initiatives that support the Purpose. This collaboration may include, but is not limited to, Monthly pickups, Workshop once a year (on campus), Seminar in Udaan, Green Certificate.
2. **Duration:** The Memorandum of Understanding (MOU) will start on 12 August 2023 and remain effective for a duration of 12 months, with the possibility of renewal afterward unless terminated by either party in writing with specific Notice Period of 30 days.
3. **Roles and Responsibilities:**
 - a. **Dry Waste Pickup Scheduling and Coordination:** Dry Waste (Material List is provided in Point 9) Pickup will be arranged based on the quantity of waste generated. Monthly schedules for pickup will be established, and dates and times will be coordinated accordingly. Items not included in the approved list will not be collected, and the College/Institution will be accountable for their management.
 - b. **Workshop Conduct and Certification:** A week-long workshop will be organized upon the commencement of each academic year (i.e.). This workshop will include an awareness session on the first day and conclude with a summarizing session and result announcement on the last day. Students participating in the workshop will receive collaborative certificates as a recognition of their engagement. The waste produced in the workshop will be picked up by ReCircle

- c. **Collaborative Seminar by ReCircle in Major College Events:** ReCircle, will act as a green partner for major college events. They will conduct seminars during our Student Council-organized events such as Udaan. These seminars will feature speakers from ReCircle who will share their insights on sustainability and waste management.
- d. **Issuance of Green Certificates:** Aditya College has chosen to go for "Recycle for a Cause" option, where ReCircle will provide a Green Certificates of safe disposal to Aditya College of Architecture on a bi-annual basis. It will be a cumulative certificate for material collected over six months.
- e. The Recyclable Waste collected from the Aditya College may contain such information of the Company which shall be treated as confidential by ReCircle. ReCircle assure and agree that all the Recyclable Scrap collected from the Aditya College shall be used only for the purpose of Recycling the Waste and no other purpose.
- f. Aditya College will provide a point of contact from the team to coordinate the pickups on a quarterly basis. The point of contact will be present during the pickup to verify the quantity & quality of material that has been collected.
- g. The courts of Mumbai having jurisdiction, will, to the exclusion of any other, try and adjudicate any or all matters concerning or arising from this MOU.
4. **Resource Sharing:** Both parties may share relevant resources, materials, and information to achieve the objectives of the collaboration.
5. **Intellectual Property:** The MOU shall not grant any right of any nature over the trademarks/copyrights or any other intellectual property of the Aditya College, whether registered or not in favour of ReCircle and does not grant any license to ReCircle to claim usage except for using the logo of Aditya College on the website of ReCircle and social media platform to the extent of show casing the association of work between Aditya College and ReCircle and not for any reason whatsoever.
6. **Funding and Expenses:** Each party shall bear its own costs and expenses incurred in connection with the collaboration unless otherwise agreed upon in writing.
7. **Amendment:** This MOU may be amended or modified only in writing and by mutual agreement of both parties.
8. **Entire Agreement:** This MOU constitutes the entire agreement between the parties concerning the subject matter hereof and supersedes all prior agreements, understandings, and communications, whether oral or written.
9. **The categories are mentioned as such:-**
- Paper** - News Paper, Cardboard, Books, Sheets, Packaging Boards, etc.
 - Hard Plastic** - Water Bottles, Containers (Shampoo, Parcel), Toys, etc.

- c. **Soft Plastic** - Wrappers, Milk Cartons/Bags, Bubble Wraps, Polythene, Tetra Packs, etc.
- d. **Glass** - Anything that's Intact & Transportable.
- e. **Metal** - All kinds.
- f. **E-waste** - Wires, Electronics, Remotes, etc.
